### Regulations parc Ermerzand:

These regulations apply to owners, tenants and visitors of "Park Ermerzand".  
Please read this carefully to avoid any misunderstanding.

1. Everyone must refrain from all acts that are contrary to public order and morality.
2. It is prohibited to cause nuisance to others by placing materials and utensils and / or disposing of waste in places where this should not be done.
3. Dogs must be kept on a lead in the park. The owner of the dog (s) is responsible for cleaning up any excrement in the park.
4. Noise nuisance should be avoided as much as possible. There is silence in the park between 10 pm and 7 am. For visitors, compliance with this is the responsibility of the host / hostess.
5. In the park, a maximum speed of 15 km per hour applies for all vehicles and the driving direction must be observed.
6. One car is allowed per bungalow / parking space concerned. Several cars and / or cars of visitors must be parked in the parking lot outside the park or in the parking lot in front of the reception. **Parking on the roadside and on the grass is not allowed!**
7. At the parking lot outside the barrier there is a demarcated place for waste:  
Household waste must be deposited in sealed plastic bags in the appropriate compaction container (not in the waste bins on the road), glass separated in the glass container, waste paper in the covered trailer and clean plastic waste in the appropriate containers. All other waste must be disposed by yourself (Cubri at Schoonebeek. Minimum price: 10€).
8. Fences are not allowed without permission of the board. An exception applies to a partition perpendicular to the bungalow, as a separation with the neighbors, of 1.80 high and 2 meters wide (provided it remains within the boundary of the own plot). This partition must

be made of stone, wood or greenery and must look sound and tidy (well maintained). The other partitions must consist of natural greenery. Where necessary, a fence of max. 90 cm is allowed in height.

- 9.** The parking of caravans, boats, campers and trailers is not allowed. Only exception is for loading and unloading.
  
- 10.** Grubbing up trees is only allowed during the organized tree felling round and can be requested by means of a form. You can indicate with a ribbon (for sale at the reception for 20 EURO) which tree or trees are involved.
  
- 11.** The park has a construction freeze from June 15 to September 1.
  
- 12.** Running a business from the bungalow is not allowed.
  
- 13.** Please do not throw sanitary towels, tampons, damp cloth deposit in the toilet!

Damage caused by violation of one or more of the above provisions will be recovered from the perpetrator and / or liable owner.
